


CHIEF REGISTRAR'S CIRCULAR NO. 4 OF 2007

CHANGE OF NAME: MARTPROP PROPERTY TRUST SCHEME TO SA CORPORATE REAL ESTATE TRUST SCHEME

1. In terms of section 98 of the Collective Investment Schemes Control Act, 2002 (Act 45 of 2002), **MARTPROP PROPERTY TRUST SCHEME** has changed its name to **SA CORPORATE REAL ESTATE TRUST SCHEME** with effect from 15 November 2006.

The enclosed documentation of this change of name must be filed under BC No. 3 / 2007 in all offices.

2. Due to the number of deeds that have to be endorsed regarding the change of name, permission is hereby granted to endorse deeds as and when they are lodged for an act of registration.
3. Powers of attorney, consents and applications signed, and deeds registered after the **date of this circular** must reflect the new name, whilst those signed prior to this date must be accepted unaltered.
4. When relevant bonds are lodged for cancellation, it will not be necessary to endorse them in this regard, provided that the consent to cancellation refers to the change of name.
5. All offices will be supplied with rubber-stamps.
