

CHIEF REGISTRAR'S CIRCULAR NO. 8 OF 2005

CHANGE OF NAME CONCERNING STANDARD GENERAL INSURANCE COMPANY LIMITED TO NOVA LIFE LIMITED AND NOVA LIFE PARTNERS LIMITED, AND TRANSFER OF ASSETS FROM NOVA LIFE PARTNERS LIMITED TO CAPITAL ALLIANCE LIFE LIMITED

1. In terms of section 44(1)(b) of the Companies Act, 1973 (Act No. 61 of 1973), **Standard General Insurance Company Limited** (Registration No. 05/16409/06) has changed its name to **Nova Life Limited** (Registration No. 05/16409/06), with effect from 5 November 1999.

The enclosed documentation containing the above-mentioned change of name must be filed under BC No. 4 /2005 in all offices.

2. In terms of section 44(1)(b) of the Companies Act, 1973 (Act No. 61 of 1973) **Nova Life Limited** (Registration No. 05/16409/06) has changed its name to **Nova Life Partners Limited** (Registration No. 1943/016409/06), with effect from 26 September 2000.

The enclosed documentation containing the above-mentioned change of name must be filed under BC No. 5 /2005 in all offices.

3. **Nova Life Limited** (Registration No. 05/16409/06) (now known as **Nova Life Partners Limited** (Registration No. 1943/016409/06), has transferred its "Long-Term Assets" and "Long-Term Insurance Business" to **Capital Alliance Life Limited** (Registration No. 1969/08187/06), with effect from 31 March 1999.

The enclosed documentation containing the transfer agreement between Capital Alliance Life Limited and Nova Life Limited, together with the Order of Court confirming the Transfer Agreement must be filed under BC No. 6 /2005 in all offices.

4. Due to the number of deeds that have to be endorsed regarding the changes of name and transfer permission is hereby granted to endorse deeds as and when they are lodged for an act of registration.
5. Powers of attorney, consents and applications signed, and deeds registered must reflect the new situation.
6. When relevant bonds are lodged for cancellation, it will not be necessary to endorse them in this regard, provided that the consent to cancellation refers to the new situation.
7. All offices will be supplied with rubber-stamps.
