## PURPOSE:

The purpose of the Workshop is to familiarise participants with the major changes to corporate law that will be effected by the Companies Act 71 of 2008 when it comes into force during 2010.

# WHO SHOULD ATTEND?

Attorneys & Candidate Attorneys dealing with the law relating to companies or close corporations.

Preference will be given to persons within the relevant province and within a 100km radius of the venue.

## CONTENT:

The Companies Act 71 of 2008 will be covered in general, with the emphasis on new developments and changes to existing principles, such as the simplified registration procedure for companies, codified duties and powers of directors, orders of delinquency and probation against directors, abolition of some common-law principles such as the doctrine of disclosure and the doctrine of constructive notice, the appraisal remedy of shareholders, business rescue proceedings, the new compromise procedures, fundamental transactions and many others.

## OUTCOME:

After attending this seminar, participants should have a solid basic knowledge of the most important provisions of the Companies Act of 2008 and be aware of the many major changes brought about by the new Act, enabling them to deal with problems encountered by clients in this field of the law.
