ABOUT THE 2-DAY WORKSHOP

- 1) provide the skills and techniques for efficient and successful High Court litigation;

- 3) assist attorneys to obtain favourable outcomes when litigating on a contingency basis;
- 4) discuss the rules regarding Motion Court practice, for opposed, unopposed and urgent applications;
- 5) discuss the techniques for effective trial preparation, including pre-trial procedure; and
- 6) demonstrate preparing the facts for purposes of trial.

The workshop will be led by Adv Ismail Hussain SC who is a former Judge of the High Court and Competition Appeal Court. He has been a popular LEAD trainer for many years.
