

## Evictions and Rental Recovery Workshop – New Content



### About the workshop

The workshop focuses on the practical application of the theory of eviction law. Both residential and commercial evictions are covered.

The workshop is not a repeat of the 2012 workshop and, therefore, will benefit first time attendees as well as attendees of previous eviction law seminars.

### Topics to be included

- Commercial evictions: High Court and Magistrate's Court.
- Residential evictions: Prevention of Illegal Evictions from and Unlawful Occupation of Land Act 19 of 1998 (PIE Act); Extension of Security of Tenure Act (ESTA); High Court and Magistrate's Court; action and motion procedure; and rental claims.
