REGISTRAR'S CIRCULAR 1/2016

<u>Subject:</u> Property description of Jamestown, Stellenbosch, Western Cape and Jamestown, Aliwal North, Eastern Cape

1. Background

- The Office of the Registrar of Deeds, Cape Town has in its records a township called "Jamestown" situated in Aliwal North, Eastern Cape.
- A second township also called "Jamestown" but situated in Stellenbosch, Western Cape has been approved by the Office of the Surveyor-General Cape Town.
- The recoding of two townships with the same name in the records of the Deeds Office presented practical difficulties.
- The Deeds Office Cape Town will deal with the recording of the Stellenbosch townships in its database and ancillary matters relating thereto as set out below.
