**PROCLAMATION NO. R. 31 OF 2018****by the President of the Republic of South Africa****COMMENCEMENT OF CERTAIN SECTIONS OF THE LEGAL PRACTICE ACT, 2014**

Under section 120 of the Legal Practice Act, 2014 (Act No. 28 of 2014) (“the Act”), I hereby, by means of the accompanying proclamation in English and isiXhosa, fix —

- (a) 31 October 2018 as the date on which Chapter 2 of the Act, with the exclusion of section 14, shall come into operation; and
- (b) 1 November 2018 as the date on which—
  - (i) Chapter 1;
  - (ii) Chapter 3, with the exclusion of section 35(1), (2), (3) and (7) up to and including (12);
  - (iii) Chapter 4 with the exclusion of sections 37(5)(e)(ii), 40(1)(b)(ii) and (7)(b), 41 and 42;
  - (iv) Chapters 6 and 7;
  - (v) Chapter 8, with the exclusion of section 93(5);
  - (vi) Chapter 9, with the exclusion of section 95(2); and
  - (vii) Parts 3 and 4 of Chapter 10, of the Act shall come into operation.

  - (vi) iSahluko 9, ngaphandle kwesiqendu 95(2); kunye
  - (vii) namaCandelo 3 no-4 eSahluko 10.
